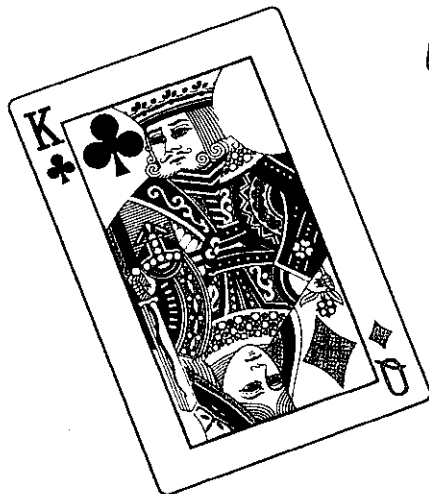

ACTION

1. The minutes of the last meeting were read and adopted with the following changes:

2 Matters Arising

No action should be taken by AC for item (1)

3(a) PABF Championships 1997

The third line of the last paragraph should read "the Youth Team would have benefited from the guidance and encouragement of their captain."

4(e) Membership cards

Action should be taken by CCW instead of CC.

4(g) Venue ('the clubhouse')

The last sentence should read "all future tournament (with certain specified exceptions) would be held there" and no action should be taken by CB/AL.

2. Matters Arising

--CC still to write to our bank.

--Captain's Report had not been submitted by the captains of the Open Team and Youth Team for PABF Championships 1997.

3. Progress on Various Matters.

(a) ICBC Intercity 1997

Not too many entries were received from overseas because (i) invitation letters were sent out late i.e. after PABF Championships was over, (ii) visa procedures for Chinese teams would not be known until 15/7/97. Council members are encouraged refer possible entries to IH or DZ for follow up.

It was resolved that due to insufficient preparation time, Inter-Hong Invitational Team Championship will not be held during Intercity

unless a special co-ordinator is. Instead, invitation letters will be sent to these companies for participation in Swiss Team event.

(b) Tournament in Shenzhen

At last, 5 teams, instead of 4, represented Hong Kong in this tournament because (i) the organiser was willing to accept additional entry from the Association, (ii) one of the 4 teams chosen by the Association had to change their line up but this would not be fair to the other teams since they did not have the chance to improve their average Master Point per team.

CB will reply to S.K. Luk on his complaint together with his complaint CB letter, the reply will be published in the next Bridgette.

It was resolved that trial format should be set before announcement is sent to members. If time is not allowed for trial, early entries will have priority in representing the Association in such tournament.

(c) Hongkong-Shanghai Intercity 1997

No progress

(d) Membership Cards

It was resolved that the Association's chop will be embossed on the membership cards. They will be distributed by responsible tournament directors during tournaments within the next 2 weeks. CCW will co-ordinate the issuance of membership cards.

(f) Computer Programme

To be completed in July.

(g) Venue

The participation rate was extremely low for new events and marginally okay for other events.

It was resolved that to maximise utilisation and to encourage active participation. (i) Senior & Youth Pair and Special Pairs (held in conjunction with Ladder Pair A or Ladder Team (A) will be substituted by Swiss Team and Combination Pairs on alternate weeks; (ii) IMP Pairs will be scheduled on Tuesdays since the Mughal can accept extra tables; (iii) Ladder Team A & B will be held together; (iv) relegated teams or pairs may not participate in the next lower Ladder events; (v) If less than 7 teams take part in Ladderette Team A, the responsible director may vary the number of boards played each round; (vi) Student Pairs will still be held since examination is over; (vii) pre-registration can be accepted by director if tournament fee is paid in full by one of the pairs or team member. If not all of the pairs or team members are present when the tournament begins, they will be replaced by other late entries and refund will be made to these pairs or team. In future, tournament begins at 7:00 pm on weekdays or 2:30 pm on Sundays while registration closes 15 minutes before tournament begins.

CCW/AL will revise the tournament schedule for August onwards and advise AC the changes for scheduling directors. The revised schedule will be published on notice board. CCW/AL

Directors should remind players to clean up the tables before leaving. It was resolved that one more rubbish bin should be installed for the disposal of soft drink cans and microphone should be set up for director use. AI /IH

Notice will be put on the notice board to remind smoking players not to leave their cigarette ends all over the corridor. AL/IH

In case of emergencies, directors can contact AL or IH.

Directors are reminded to arrive at the venue at least half an hour earlier than tournament registration begins.

It was resolved that keys to the clubhouse will be distributed to all council members and directors.

AL will draft a code to directors so that they can ask the players to observe during tournaments. AL

4. A.O.B.

(a) Tournament in Shanghai
DZ has replied to the organiser that due to uncertainty in availability of air tickets, no member has expressed interest in this event. So, no team will represent Hong Kong in this event.

(b) The Guangzhou-HK-Macau Triangular Interport tournament will be held on 26/7/1997 at . The winner and first runner up of Open Team of Four will represent Hong Kong in this event.

(c) Chow Ka Yan has passed the director examination. The council endorses her to be qualified director.

(d) The lecturing portion of the new round of director course is over and apprentices begin to assist in regular tournaments.

(e) The clubhouse can be booked by members for use also by non members.

1. Progress on Various Matters

(a) ICBC Intercity 1997

23 overseas teams have already sent their entries, with 11 from China, 6 from Taiwan, 3 from Japan and 1 each from U.K., the Philippines and Singapore, other than the Hong Kong Ladies Team and 8 local teams qualifies through the Trial; AC expected to receive 8 more entries from overseas (3 from China, 2 from Indonesia and 1 from Macau). Altogether, there may be 38 teams. It was resolved that (i) there will not be any separate Ladies section; (ii) the 9th and 10th placed teams in the Trial will be allowed to play in the Open section while the 11th and 12th placed teams will be on standby to round up the total number of teams to 40.

AC advised that 21 more room nights is needed to meet the guaranteed room night figure. Otherwise, a penalty of up to HK\$30,000 will be levied by Regal Kowloon Hotel.

All equipment and supplies will be ready before the tournament begins. As some sponsors introduced by Lawrence Lau have not specified their advertisement, AC will ask Ashley Lung to wait a few more days to allow ample time for Lawrence Lau to finalise that with those sponsors. Other souvenirs are on hand.

ICBC will send their representative to officiate the opening of the event at Welcome Lunch and to present prizes at Victory Dinner. Robert Zajac will be the Master of Ceremony for both functions. Sherry Stone will be asked to assist him.

8 teams have enrolled for Inter-Hong which will be organised by Stephen Kwok and held in conjunction with Swiss Team.

(b) Guangzhou-HK-Macau Intercity

The two teams from Hong Kong were 5th and 6th placed in the event.

2. A.O.B.

(a) AC advised that the China Bridge Association has since changed her fax number.

- (b) A fax from PABF Secretariat was tabled for discussion. CB will ask the Amateur Sports Federation and Olympic Committee whether the name of the Association should be changed to "Chinese-Hong Kong Contract Bridge Association" when representing Hong Kong in overseas tournaments in future.
- (c) In view of the disappointing attendance in new events held on Mondays and Wednesdays, it was resolved that Student Pairs, Combination Pairs and Swiss Teams originally scheduled after 1/9/97 will be canceled. The Association is considering to hold cash prize tournaments after October. AL will consult CB whether such arrangement will violate our Constitution. Since Ladder Team 5 (others) scheduled on 1/8/1997 was canceled because of Typhoon Victor, it is now rescheduled to 29/8/97 (Friday). In this connection, Ladder Team 6 (A) & (B) and Ladder Team 6 (others) will be rescheduled to 3/9/97 and 10/9/97 (Wednesday). CCW will ask Chin Lok Hang to inform the teams concerned.

1. **The Minutes of the Fifth and Sixth Council Meetings were read and adopted with the following changes:**

Fifth Meeting, para 3(g): This should read as 'ALL to prepare a check-list on using the facilities at the Clubhouse'

Sixth Meeting, para 3(a): This should read as '21 more rooms were needed to meet the guaranteed room night figure. Otherwise, a penalty of up to HK\$40,000 will be levied by the Kowloon Regal Hotel.'

2. **Matters Arising**

- CC still to write to our bank ACTION

- The captains' Reports from the captains of the Open Team (WY Sit) and Youth Team (Dr. K F Tung) at the PABF Championships 1997 were accepted with reluctance.
- CB will draft a letter in response to SK Luk's letter of 12th June, 1997 CB
- Membership cards were now ready for distribution CCW
- CCW and AL had prepared a revised tournament schedule up to the end of the year
- CB to write to the Amateur Sports Federation and Olympic Committee regarding the name to be used by the Association when participating in overseas tournaments. CB

3. **Progress on Various Matters**

- (a) HK - Shanghai Interport
This will be held on either 8th - 9th or 22nd - 23rd November.
- (b) Computer Programme
AC had no time to check on current progress
- (c) Venue
It was noted that (i) a number of members had expressed a desire for more pairs events and for the team events to be held on days other than Tuesdays and Fridays; (ii) there were differing views amongst members as to the desirability of holding tournaments on week-ends and (iii) the Council's aim was to try and achieve a balance. Resolved that: (i) events would be scheduled on Mondays, Tuesdays, Fridays and non-racing week-ends; (ii) Mondays would be assigned for pairs with trials being held on week-ends; (iii) the year - round events would be abandoned with effect from next year and events with a shorter cycle introduced; (iv) as there had been so many changes to the schedule of tournaments, the present schedule up until 31st December, 1997 would stand.
CB raised the question of the Clubhouse being used for bridge lessons in the morning, as a result of a specific request made to her by a member. Agreed that this could be done at a cost of \$ 100 per table.
- (d) ICBC Intercity 1997
AC reported that 39 teams had participated in this event. It was noted that despite the penalty levied by the Regal Kowloon, it was likely that there was a surplus. We were currently awaiting CC's final figures. AC also reported that next year's Inter-City would have to be held in late July. In view of the disappointing service rendered by the Regal Hotel this year, it was likely that the event would be moved to a different venue.
AC also reported on the following: (i) new laws had been introduced which were effective from 1st September 1997; (ii) Chris

Fung had qualified as a director. (iii) our equipment in the Mariners Club and Chung Ngan Club had to be moved by the end of the year, (iv) the printer in the Clubhouse needed a new adaptor. (v) we only had 40 sets of bidding boxes left and a new order would have to be placed; (vi) new screens were required for the PABF trials.

RESOLVED that the following persons take the following action: (i) IH to order new law books; (ii) CY to circulate an announcement to members regarding the qualification of Mr. Fung, (iii) IH to remove the equipment; (iv) IH and AC to attend to new adaptor, (iv) AC to order new screens.

- (e) Sir David Trench Fund
JM to follow up on this matter.

4. **Any Other Business**

(a) Century Cup Pairs

Noted that in order to participate in this event, the partnership must exceed 100 years of age. This would be held on 28th - 30th October, 1997; the teams event would take place on 2-3rd November, 1997. An announcement would be posted at the Clubhouse and on our website. B. Zajac would be also be informed so that the information could be published in the SCMP.

(b) PABF 1998

This was scheduled to be held in Kobe, Japan in May 1998. Entries consisted of Ladies, Open and Youth. AGREED that (i) registration for trials must be made before 31st October, 1997; (ii) both the Ladies and Open Teams would receive a subsidy of \$10,000 each from the HKCBA, half of which would go to the non-playing Captains; (iii) the Youth Team would receive a subsidy of \$15,000 of which \$5,000 would go to their Captain; (iv) entries for the trials would be \$6,000 per team for the Ladies and Open and \$50 per pair per session for the Youth Team; (v) the format of the Ladies and Open trials would be determined by the no. of entries; the Youth trials would be by pairs.

(c) Request by Nicki Marr to play in the World Transnational Open Teams Even in Hammamet, Tunisia

Noted that Ms. Marr was not representing HK and that there was no objection provided she was a HKCBA member.

5. **Date of Next Meeting**

The next Council Meeting will be held on 13th October, 1997 at 6:30 pm. There being no other business, the meeting adjourned at 8:10 pm.

South was Helgemo. HK was led, ruffed then DA. He took stock. A 3-3 spade break would mean immediate success, however the opening 2H bid was an indication that the other major would likely be short, hoping they were something like 8x, Helgemo played Sx towards dummy inserting the 7. Later on he entered dummy twice playing Spade from top down finessing east's honors to land his contract. Admittedly a Club lead could kill the slam but would do that on the bidding?

MAVERICKS ON THE NET

The Continuing Episode of Okbridge

As a promotional gimmick, Okbridge regularly lines up 'named players' to perform exhibition matches. Sometimes, without prior announcement, those 'named players' would drop in unannounced and play a session or two at their own leisure. So anyone can run into Meckstroth, Simpson, Soloway or Goldman on a good day.

One evening, after logging on, I spotted a table with 50 kibitzers and I naturally joined to see who was putting up a show. As it turned out, it was Richard Pavlicek (bridge teacher and author from Florida, 12000 Master Points, many times US national champion) partnering David Feldman (from New York, inventor of CRASH, also countless national wins). They were facing two bridge pros from Miami.

Luckily for me, the first hand I watched was a gem:

With the benefit of seeing all four hands, the kibitzers knew the contract was going to be a struggle and expected action. West led a fourth-best diamond and declarer ducked two rounds, taking the third

while discarding a club from dummy. He next played the ♥4 to dummy's king, which held. Now ♣Q, riding, getting the good news and bad news. On this trick, West shed a heart. A second club finesse saw West discarding a spade and Pavlicek now made the key play - he cashed the ♣A, applying intolerable pressure on West. We all know that a spade discard would put declarer to a guess but who would blame West for throwing another heart - after all, the spot cards were so far inconclusive. As a result, declarer could comfortably establish a third heart trick to chalk up his contract.

There was admiration and gasps around the 'room'. "Nicely done," observed some kibitzers.

Could the defense do better? Yes, at trick four, if West made the strange looking play of going up with the heart ace and cashed the fourth diamond, declarer would be squeezed out of his squeeze threat (if this makes any sense to you). He could not afford a spade, nor a heart, nor a club. At first glance, when the king queen of hearts were played, East appeared to be the victim of a spade-club squeeze but remember, dummy had to find a discard on the fourth diamond - in other words, dummy would be squeezed before East.

So the fourth diamond in essence squeezed both dummy and declarer at the same time. Honestly, I have never seen a hand like this before. And how would you call this coup? Perhaps a simultaneous, preemptive /reciprocal double squeeze by the defense? Amazing.

The next board was an opportunity for Feldman to show off his skills. (Direction switched 180 degrees)

For some reason, East opened proceedings with 1S. Presumably, their weak two openings promised a lot less, as is in vogue in North America, Feldman paused to take stock and emerged with a 2C overcall. Looking at the enormous NS misfit, the kibitzers sensed blood. West trap-passed and Pavlicek bid an innocent 2H, non-forcing. This was passed around to West, who promptly doubled - "even better, I held both the opponents' suit" he thought.

This was passed back to South who, at this point, must be regretting the whole affair. He scrambled with 3D, hoping to find a better landing spot. Miraculously, nobody doubled. It was a sort of anti-climax to see if declarer could bring home the bacon.

West chose to lead a small club (a trump would be a more normal play but as we shall see, the contract could not be defeated). Feldman ruffed this instinctively in dummy and all of a sudden, the contract seemed doomed. He recovered well to play the heart king, putting West back on play. She made a club exit (again, not that a trump mattered) and dummy scored another ruff. Now declarer cashed the ♦K and ruffed a heart back to hand. The trump ace was cashed and declarer played out the two winning clubs. East could score his trump queen anytime but it was only a question of when to take the poison. Eventually, he could not avoid being end-played to allow dummy to score a spade for the ninth trick. I should mention that the play was fast and crisp and took less than a minute. Could Feldman have visualized the ending at trick one? God knows.

In case you are wondering, a more natural line would be to win the first trick in hand and advance a heart, West took this trick and the best return was another heart, taken by the king. Now declarer could draw two rounds of trumps before ruffing a club in dummy. This essentially created the same ending as the other line and East could be thrown in likewise.

Well, in any event, that was high quality bridge and I, for one, am surely going back to watch more if I can find the time.

The Hand That Decided The 1997 China Cup (Open Series)

The China Cup was a Marlboro sponsored, all expenses paid event for the promotion of bridge in China for a continuous 3 years, this year it was held in Chengdu, August, 1997.

Derek Zen, our chairman was invited as the chief commentator, he was also on the Appeals Committee, Anthony Ching, our vice, was the chief tournament director, being probably the best in the region. Bobby Zajac was also there assisting Henry Francis, an expert in running daily bulletins in major tournaments.

The Open Event consisted of 4 teams: China, the same team that took part in our Intercity this year, average age 31.5; America, 6 pros from USA and Canada; Europe, 6 Polish European/World champions and All Stars, Patrick Huang-CH. Kuo of Taiwan and Mannoppo-Lasut, Indonesia. The format was a double round-robin, 32 boards and 6 matches in 3 days. China, America and Stars were neck to neck all the way till this hand came along, about the fifth last and all 3 reached 6S, as expected:

The 1997 Revised Laws of Duplicate Contract Bridge

by Anthony Ching

The latest revision of the Laws took effects from 1 September 1997. Many of the changes are significant. The following table summarises the changes that have taken place, with comments where appropriate. This should be read together with the Law Book, copies of each can be ordered through Irene Ho.

this very hand would mean China crowning champs. In the China vs America match, CA was led in both rooms. China ruffed and passed a small trump and the Cup. America played small trump to hand's SK to take the championship. Patrick Huang had no chance, the singleton Heart was led and North gave a ruff as soon as a trump was played. Europe stopped in game in the other room.

Everyone knew it was a deciding board, to bid or not to bid the slam, slowly or real fast, sacrifice or not, etc. Derek asked Pat's view afterwards. He said it was close decisions, bidding at his table was 1H-1S-2D(forcing)-2S-6S. Patrick commented that had CH. Kuo subtly used Blackwood before landing the slam anyway, south might, as in the other match, lead the Club Ace for a look, the abrupt jump warned him of a possible void.

The ladies Event was run in parallel format, China fielded the same 3 pairs that took the World runners-up this year; America were 6 pros from USA, Europe was a combined German, French and Dutch ladies with innumerous titles and Egypt, as The Stars and Zone 4 winners. The Appeals Committee had only 2 cases to adjudicate, but both were on the same board, and, both appealing sides were China! Perhaps next time please.
