- 1) Adopt minutes of last meeting.
- 2) Matters raised in last meeting (by minutes order):
 - a) Due to serious delay, council will terminate the contract with Appsgogo. Council has made exit agreement with Mr. Martin Poon, director of Appsgogo, who is willing to pay HKCBA HKD30,000 by the year 2016. (No action)
 - b) PC to contact Indonesia Bridge Club regarding details of the Asia Game in 2018. According to SF&OC, the minimum requirement of participant in Asia Game should be passport holder; detail guidelines will only be available in 2017. SF&OC will discuss with each NBO the requirement closer to the event date. Basically the requirement of Asia Game should not be as strict as Olympic Game. (Action by PC)
 - c) PC to contact CCBA regarding to details of Congress 2016. (Action by PC)
 - d) Regarding Asian Game 2018 issue. Council will send a letter to HK SFOC to request a letter from them to support bridge as one of items. (Action by LC)
 - e) Registration of congress shall be started and deadline set on Jan 31, 2016 (Action by TL)
 - f) Council agrees to propose in AGM that the requirement of Hong Kong representative in Zonal (APBF event, ASIA Cup etc) and World level (WBF event, mind sport event etc) are:
 - I) HKCBA member in last two year upon trial registration
 - II) HK “3 star” ID card holder, OR HK junior ID card holder if under age 18
 - III) He / she didn’t represent other NCBO in last two years upon trial registration

Council suggest above proposal to be made effective on June 1, 2016. Exemption will be grand to current youth team member. (Action by PC)
 - g) Due to availability of venue, the trial of open series of World Bridge Games will be fixed on Jan 17, 23, 24, 30, 31.
 - h) Council agrees the total entry fee of trial should be at least cover cost occurred.
 - i) Mixed team trial will be held if necessary.

3) Financial Affairs:

- a) Latest Bank Balance: HKD1.26 million.

4) Internal Affairs:

- a) One pair (Vincent Li's pair) didn't show up in the second session of Tom Wong Swiss Pair and it is unfair to other players. Council will send a warning letter to this pair. (Action by PC)

5) External Affairs:

- a) Council decided to cut the no. of LCSD classes as the subsidy for bridge teachers is too low (HKD179 per hour). (Action by KF)
- b) The subsidy of registration fee for open, ladies, youth and senior representative team in zonal or world level events is set at maximum HKD20,000 per team. If the registration fee exceeds the said limit, the rest should be paid by the team.

這裡我指的是你和同伴聯手共有 2 套牌配合，每套聯手都有 8 張，你將選擇 4-4 配合的牌還是 5-3 配合的牌做將牌，或者我寫出實際牌例：

Here, I mean that you and partner have fit in 2 suits. For each suit, you have 8 trumps in total. Will you choose the one with 4-4 fit or 5-3 fit? Let me write the real life example:

這桌的南叫 X，除表示牌力外，可能還表示有另一套高花♥，叫的很好。

恐怕一般人都認為打 4-4 分配比 5-3 分配好，實際上，還要看對方這 2 套花色的分配，如果都是 2-3 分配，那麼，以 4-4 花色做將牌時，有時會多得 1 墩，但是你無法知道對方的牌型分配，所以你不能認為任何時候 4-4 將牌一定優於 5-3 將牌。請看實際的 4 手牌

South at this table doubled, indicating that in addition to strength, he had another major suit ♥. He bid very well. Most people would regard playing 4-4 trump fit is better than 5-3 fit. In reality, you still need to consider the distributions of the 2 suits in opponents' hands. If they are 2-3, then you may have one more trick if you have 4-4 trump fit. However, there is no way for you to know the opponents' distributions. Therefore, you cannot consider that playing 4-4 trump fit is better than 5-3 trump fit all the times. Please watch the 4 hands:

2 桌都首引 2 墩♣，4♠有 10 墩，4♥只有 9 墩，因為東西的將牌♥是 4-1 分配。實際的牌張分配，一定要輸 1 墩♥。

The 1st 2 tricks were ♣s at both tables. You have 10 tricks for 4♠, but only 9 tricks for 4♥ because the ♥s in East and West were distributed 4-1. Based on the actual distribution, one ♥ must be lost.

這副牌出現在 2015 年第 37 屆 ASEAN bridge club championships 最後一輪排位賽上。在 BBO 上見到對陣一方是 Zen Team，他們以 25:19 贏得這場比賽，但這副牌，叫得好，因為東西的♥是 4-1 分配，輸掉 13IMP。可見橋牌在很多地方沒有《絕對》，還有你無法考慮到的對方的牌型分佈。

This board appeared at last round of Swiss Team of the 37th ASEAN Bridge Club Championships in 2015. I watched Zen team play this round on BBO. They won 25:19 in this round. However, this board was bid well because the ♥s in East and West were 4-1. They lost 13 IMPs for this board. It can be seen that nothing is “absolute” at bridge. You cannot estimate the distributions in opponents’ hands correctly.

高階爭叫

Competing at High Levels

高階爭叫，即使你是高手，也有很多牌，相信你一定會處理失當。

這裡以 2015 年 10 月舉行的 Bermuda 盃決賽，即波蘭對瑞典比賽中的幾副牌來說明，實際很多是判斷或者說是猜牌，即使是頂尖高手，也不一定每次猜對。

When competing at high level, even you are an expert, you may treat wrongly. I shall illustrate with some examples which happened at the Final Competition of Bermuda Bowl held in October 2015 between Poland and Sweden. For some judgements or guesses, even top players may not guess them right.

同伴北在有局方，已經叫過 2NT，現在第 2 次再度讓你叫牌，說明他有額外的牌型，也即 2 套低花，至少是 6-5，你的防守贏墩只有 1.5 墩，同伴能有 3 個贏墩嗎？你會叫 5♣，5♦，Pass，4NT（讓同伴選將牌）。我想多數人可能選擇不叫。

Partner sitting North bid 2NT when vulnerable and he doubled to ask you to bid again, indicating that he has extra shape, i.e., 2 minors, at least 6-5 in length. You have only 1.5 defensive tricks, can partner have 3 winning tricks? Would you bid 5♣, 5♦, Pass or 4NT (i.e., to let partner to choose trump suit)? I think the majority of people would choose to pass.

在波蘭對瑞典的二桌上，前 2 輪叫品一樣，波蘭隊南家選擇不叫，另一桌叫牌如下：

At the 2 tables of Poland versus Sweden the 1st 2 rounds of bidding were the same. South of Poland team chose to pass. At the other table, the bids continued as follows:

Against the contract of 5♦, the 1st lead was the ♠A, followed by a ♣ down 1.

Against the contract of 4♥, the first lead was the ♣A, following by the ♠K. Declarer made 10 tricks.

What will you bid? First, do you consider that they can make 5♦? Partner bid 4♠, and should not have many winning tricks. Your defensive trick may be the ♥A, and perhaps the ♣K can be counted as half a trick. Poland's South judged correctly and he bid 5♠.

對 5♦ 合約，首引♠，明手將，出♥5，南♥A，回♦4到明手♦J，莊家用♥Q回手，再將第 2 張♠，大將吃小♥回手，清將，最後一張♠墊在♥K下，5♦超一完成。

Against the contract of 5♦, the 1st lead was a ♠, trumped in dummy. Declarer played the ♥5, South ♥A and returned the ♦4 to Dummy's ♦J. Declarer returned to hand by the ♥Q and trumped one more ♠s. Declarer returned to hand by ruffing high of a small ♥, drew trumps and discarded the last ♠ under the ♥K, 5♦ was made up 1.

對 5♠合約，加倍下 2，波蘭隊勝 12 IMP.

The contract of 5♠(X) was down 2. Poland Team won 12 IMPs.

The 1st rounds of bids at both tables were the same. 2NT indicated the ♣ and ♥ suits. Now, it's your turn. What will your bid? I consider that Sweden's East bid well.

He cuebid 3♣, which should indicate that he had an opening hand and ♦ fit. They stopped at 5♦. With fit, the bids should be more proactive.

再說南家做莊4♥打牌過程，首引♥8，東♥Q，回♦4到西♦A，出♠A，第4墩♦J，他不知道同伴5張♦吧！被莊家將吃墊牌，墊去♣失張，結果只下1。

Then, I shall talk about how South played the contract of 4♥ as Declarer. 1st lead was the ♥8, East ♥Q, returned the ♦4 to West's ♦A, played the ♠A, played

♦J at Trick 4. Likely, he did not know that partner had 5 times ♦! Declarer ruffed and discarded a ♣ loser, the result was down 1 only.

另桌 5♦，首引♥A，很容易打成。瑞典隊勝 10IMP。

At the other table, 5♦ was easily made on the 1st lead of the ♥A. Sweden Team won 10 IMPs.

一共有 12 隊打相同的牌，除上述 2 隊外，還有爭奪 Bermuda 盃季軍的美國 2 隊對英國，以及 Venice 盃，跨國賽 各 4 隊。（各 2 隊爭冠軍，2 隊爭季軍）

A total of 12 teams played the same boards. In addition to the above 2 teams, there were also USA2 and England competing for the 1st runner-ups of Bermuda Bowl, as well as 8 other teams in Venice Cup, and Transnational Teams (2 teams competed for the Champion and 2 teams competed for the 1st runner-up).

這 12 隊的隊員，能進入前 4 名的，都應該是高手了吧，但是他們對高階爭叫的判斷，和實際牌型，有的相差很遠。我們拿牌例 1 來說吧。其他 10 桌中有 8 桌是東西方打 4♥，4♥X，5♥X，最離譜是有一桌打 6♥X，他們是這樣叫牌：

The players of these 12 teams were among the top 4 teams and should be experts. However, their judgements at high level concerning shapes deviated a lot.

From the 1st example, East and West played 4♥，4♥X，5♥X，and the most ridiculous one was 6♥X at 8 out of 10 tables. Their bids were as follows:

結果下 2。還有 2 桌，一桌是 5♣ 下一，正常。一桌是 5♣ 加倍被打成。這桌的叫牌判斷正確，但不太難的防守上失誤，西家首引 ♠3 到 ♠A，第 2 墩東回 ♣9 被打成。只有回 ♠，沒有辦法打成，可見高手的錯還是不少。

The result was down 2. 5♣ was down 1 at one table while 5♣(X) was made at the remaining table. The bids at this table was judged correctly but the opponents made mistakes in the not too difficult defense. West led the ♠3 to the ♠A. At trick 2, East returned the ♣9 and 5♣(X) was made. If he returned a ♠, the contract could not be made. It indicates that experts could also make quite a number of mistakes.
